# Minutes of Council Meeting held Monday, 4 April 7.30pm in the Necton Rural Community Centre

#### 1. To approve apologies for absence

Apologies received & accepted from Cllr Woodward (personal) and Cllr Cheshire (personal). Apologies also received from Cllr Kiddle-Morris (other meetings). The Chairman, on behalf of the Council, sent good wishes to Cllr Cheshire and the arrival of his new grandson.

The resignation of Mrs Christine Tilbury on 30 March was also noted and Breckland Council have been notified.

#### 2. Declarations of interest

No declarations of pecuniary interest were noted.

#### 3. To consider the co-option of Mr Clive Pellett to the Parish Council

Cllr Thompson proposed and all agreed to co-opt Mr Pellett to the Parish Council. Mr Pellett was welcomed to the table by the Chairman and he signed the Acceptance of Office form in the presence of the Clerk. The Chairman also took this opportunity to express his thanks to all members for their diligence and hard work during the period of low member numbers.

# 4. To approve minutes of Council meeting

Minutes of Council meeting held on 07 March 2016 were confirmed as a correct record and duly signed by the Chairman.

#### 5. To report progress on items not on the agenda from last meeting

The Clerk provided a written report to Councillors prior to the meeting and summarised some key points.

- The flooding of the river Wissey has been notified to NCC. A resident has advised that the recent storm has taken a tree down into the river and across the pumping station.
- Update on St Andrew's Lane land: (Breckland Council improvement works) Further news anticipated at end of April. The Clerk has updated one of the residents, who will share the information.
- Road markings for School drop off: This work is expected to be carried out during April by NCC.
- Damage to play area caused by ongoing drainage system: The Tun's Road drainage system is inadequate and floods into the play area and basketball court when raining. NCC Highways are investigating the installation of 3 new soak away chambers set in between the trees in the carpark. This will work but with the shortest lifespan. It is also dependant on a geological survey to establish if the subsoil is permeable.
- NCC Highway's rangers are next due in the village on week commencing 16 May.
- Anti-social behaviour in the village: Tracy Baxter, Senior Community Safety & ASB Officer, Breckland Council, has stated that she will inform PCSO Dave Ready of the incidents reported.
- Hale Road Trod is now scheduled for week commencing 23 May. It has slipped due to NCC resource issues.

#### 6. Reports from:

Cllr Mark Kiddle-Morris, Norfolk County Council: by telephone to Clerk:

- The policing of car parking on junctions is a police enforcement matter. It is a breach of the highway code to park within 15 metres of a junction, but with limited resources, the police are unlikely to monitor.
- Will be attending the Annual Parish Meeting.

#### Cllr Nigel Wilkin, Breckland Council:

- Went to the site of the roadworks on St Andrew's Lane. The roadworks will cause complications to residents as the road will be dug up.
- The matter raised last month regarding ditch collapse is in hand, with a plan by landowner to take action later in the season once the land dries out.
- There has been a leadership change at Breckland Council, with new leader now William Nunn.
- Devolution discussions are currently "a moving feast" and no fixed views by Breckland Council at present.
- EU debate was raised by UKIP, however it was agreed that Breckland Council would not vote on this matter as it was for individual consideration.
- A47 agreed works appear to be slipping out of the works schedule as budgets are being re-assigned. This
  matter continues.

# Meeting adjourned for Public Participation Session at 7.55 pm

- The streetlight on corner of Hale Road and Chantry Lane was misaligned in the recent storm.
- The lack of crime figures for the village was noted as the new police systems are still not providing this data in extractable format.

# 8.3 To receive update on Local Plan

The Local Plan Preferred Options consultation received 2,600 comments and 119 new sites across the district had been put forward. Officers are preparing a report and their next meeting is still to be arranged. Cllr Matthews advised that he and the Clerk are meeting with Breckland Officers on 7 April 2016 to discuss planning within the village. Cllr Wilkin will also be present at this meeting.

# 8.4 To consider the current Technical Consultation on Implementation of Planning Changes as outlined in "LAIS1338 Planning Changes"

Cllr Matthews advised that Norfolk ALC is currently drafting a response to this consultation, which will be circulated to member councils for their consideration. Cllr Wilkin noted that some of these proposed changes may have an impact on social housing development.

# 10. To consider and adopt a new Training & Development Policy

#### 13.2 Terms of reference

It was agreed that this committee would have delegated authority to manage the trusteeship of the NRCC in accordance with the Parish Council standing orders, financial regulations and other governing documents. A detailed terms of reference will be drawn up to be presented at next full council meeting.

Meetings will be held bi-monthly on a Monday evening at 7 pm. The Clerk will publish and circulate a schedule.
