5. New applications to vote by proxy at this election must reach the Electoral Registration Officer at ELIZABETH HOUSE, WALPOLE LOKE, DEREHAM, NORFOLK, NR19 1EE by 5 pm on Tuesday, 28th April 2015.
6. Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after 5 pm on Tuesday, 28th April 2015, must reach the Electoral Registration Officer at ELIZABETH HOUSE, WALPOLE LOKE, DEREHAM, NORFOLK, NR19 1EE by 5 pm on Thursday, 7th May 2015
