What we did during the year

Significant events 2015/16

- Award of Foundation status in September, with good feedback from assessors.
- Parish Council of the Week by NALC as recognition of our award status.
- New Parish Office helping to increase our engagement with community, many visitors during opening hours.
- Trusteeship of NRCC ensuring it remains open.
- Transfer of financial responsibility of the children's play area and outdoor gym area from NRCC and into the PC, enabling these village assets to be supported by the precept.
- Allotment Society has established a sound financial and management base and increase in plot holders.
- Local Grants awarded by the Parish Council A total of £1,726.10 awarded locally.

Resident issues & what we did to help

- Dog fouling raised awareness through articles, leaflets. Our caretaker has been washing down all our bins, making them easier to see and more inviting to use.
- Traffic congestion keeping it on the agenda with NCC Highways, calling on our Ward Members to support our cause.
- Car parking at school working with the school, site meeting with NCC Highways to discuss practical options. One such solution is the new "drop-off" zone to help keep traffic moving.
- Over development fears & Local Plan keeping this on every PC meeting agenda, meetings with Breckland Planning to keep the village voice heard, encouraging potential developers to work with us before they submit plans.
- Potholes quick reporting to NCC Highways. E.g. Our report on the Tun's Road craters was dealt with by NCC within 48 hours.
- Road signage to help alleviate oversized traffic along St Andrew's Lane and Ivy Todd, worked with NCC Highways to commission new restriction signage.
- Road names in response to residents requests for clearer road name signs for St Andrew's Way, worked with Breckland Council to commission new signs.

Infrastructure Projects

- Bus shelters on A47 already in planning stage, funding on the way.
- Hale Road Trod partnership agreement with NCC, completed June 2016.
- New surface in play area secured \$106 funds, to provide a better play area for our children.
- Lights upgrade phase 2 now complete with 61 of our 134 lights upgraded from old technology to new low cost LEDs.






Finances

Receipts during 2015/16




Grants included monies from the \$106 Mill Street fund to support improvements to our play area.

Payments during 2015/16



Employment is the council's single largest cost, providing an experienced Parish Clerk and a Village Caretaker. **Street lights** are our second highest cost, which is why the Council are keen to upgrade all its stock to more efficient LEDs.

Comparison with the previous year



Our **precept** for 2015/16 was £36,000. Our **employment** costs vary from previous year as we had a period without a Clerk. **Balances carried forward** account for the play area improvements which were not invoiced during 2015/16.

Allotments

The allotment Society has worked during the year to improve site facilities and make the site more accessible and enjoyable for new tenants. It has worked with over 50% of the site now in productive growing use by local tenants. In addition, they have secured funds to improve the access and parking arrangements (once weather permits development). They have also installed a number of benches within the allotments and in the dog-walking area.

Necton Community Centre

Necton Parish Council took over as sole trustee of Necton Rural Community Centre on the 01 October 2015. This allowed the long-standing management committee to finally retire.

The Council carry out their trustee responsibilities through the NRCC committee, which meets bi-monthly. Meetings are open to the public and minutes are published on the Parish Council's website.

The Parish Clerk is responsible for the operational activities and is supported by a long-standing Cleaner and a small team of volunteers. Recruitment is underway for a Caretaker.

Finances of the community centre are completely independent of the Parish Council finances. They are managed by the Parish Clerk and overseen by an independent internal auditor, Mrs Heather Field.

The financial year for the Community Centre is January to December. The headline figures for year end 31 December 2015 are as follows:


