# Norfolk County Council, Cllr Mark Kiddle-Morris

Stop & Go boards are usual for tar & chip operations and he will find out why the road was closed. The Leader of Council report for 2018/19 is available on the Breckland website. The local government grant for broadband was summarised.

# **Breckland Council, Cllr Nigel Wilkin**

The new pay & display car parking system in Swaffham was summarized. Garden bin figured were summarized.

#### Chairperson, Cllr Jean Bass

Continuing progress on Erne Farm, the trod, illegal burning of rubbish, youth club and homewatch were given, Ditches and drains will be the covered by the chair in the village hall on Sunday if anyone interested would like to come along. Police connect and dates of future council meeting will be put on the notice boards. A letter has been received from a parishioner asking for some improvements, appropriate action will be taken.

#### **Councillors**

A summary of the potential development on the Charnwood site was given. Speeding issues and the possibility of calming measures were discussed. The SAM has been moved and the latest speed data was summarized. A very successful film night was organized on Thursday and the money raised is to be used for a screen in the hall. It was noted that repairs to the fence by the playing field have not been done.

#### 10. To receive minutes of the recent NRCC meeting

The minutes were received.

#### 11. Necton Festival - to receive an update from Cllr Bateman

The Necton Festival was incredibly successful. £5042.50 was raised for charity. This will be split equally between EACH, Merle and the NRCC. 556 tickets were sold, each allowing free entry to two children so there were up to 1000 people at the festival during the day and evening events. Social media results were very positive. The Chair thanked Cllr Bateman for organizing such a successful event for the village.

# 12. To decide on whether the PC will support the 2020 festival with a grant again

It was proposed that the grant be increased to £3000 and £500 for marketing.

# 14. To note payments made for July 2019

These were issued prior to the meeting and agreed by e-mail with the clerk. They will be formally included with the minutes.

#### 15. To consider the turning off of street lights from midnight to save energy

The meeting was suspended for a member of the public who reported that Larwood close lighting belongs to Norfolk County Council and is already turnrd off at midnight. Cllr Mark Kiddke Morris reported an example of a set of 19 street lights that are turned off at midnight and save £44 per month in the winter. Details will be provided to the Chair. The Necton street lights are in the process of being upgraded to LED and it would be more cost-effective if the controls to turn off at midnight are put in as part of the upgrade. The cost of the controls versus the potential saving to be identified for a decision next month.

# 16. To decide whether the Council wishes to change the previous decision in March not to buy the marl pit (decision to invoke standing order 7a agreed in camera)

Cllr Phil Hayton gave a brief presentation covering the history of the marl pit, previous use by the village, the advantages of acquiring the land, the risks associated with it and the possibilities for grants to develop it as a recreational centre. The original proposal was for an auction purchase but a Community Asset Transfer (CAT) has been identified as a better route. This could be a free transfer but with Breckland's out-of-pocket costs to be paid.

It was proposed that the Parish Council apply to Breckland for consideration of a CAT of the marl pit.

Proposer: Cllr Phil Hayton Seconder: Cllr Frank Stopp

Motion carried unanimously with 3 abstentions.

The response from Breckland will be considered at the following Council meeting and should be accompanied by a report on possible contamination.
