Councillors

Councillor Jennings informed Council that a resident had stated that there is a gap in the fencing at the dog walking area which is allowing smaller dogs to escape the enclosed area. This is to be looked at.

Councillor Bateman stated that the trod near Ramms Lane was very overgrown, the Clerk will report this. He informed Council that there had been a small number of incidents at the Queen Elizabeth Memorial Wood of anti-social behavior and low level vandalism. One approach to helping to resolve this would be installation of CCTV and/or other security measures. This will be an agenda item at next month's meeting

Councillor Curtis wanted to have thanks noted for David Catlin for making some replacement wooden boxes to replace those which may have been taken from the community centre. Councillor Curtis also noted that 2 bottles of wine also appear to have been taken.

Breckland Councillor Nigel Wilkin confirmed the resurfacing works in Mill Street was now completed but the street markings had not been re-painted – the Clerk to take forward.

The first meeting was held to last week and the action plan was updated with possible actions to take forward and progress thus far. Thereafter discussions were held on projects, noting some would qualify under the Parish Partnership scheme. Thereafter it was proposed the first project should be the purchase of 3 benches- proposed by Councillor Hicks, seconded by Councillor Hayton and agreed unanimously. Thereafter the location of these was discussed and Councillor Curtis proposed these locations should be the church (by the village sign), opposite North Pickenham Road junction on a grass verge and Ramms Lane – subject to agreement from the relevant authority. Seconded by Chair Bass and agreed unanimously. The Clerk to take this forward and to also update the plan accordingly
