1. To receive nominations for the post of Chairman and elect a member to the post. Councillor Bass proposed herself, seconded by Councillor Spain. No other proposals were made. A vote by secret ballot took place and Councillor Bass received 7 votes for and 2 votes against. Thereafter Chair Bass signed the acceptance form and this was co—signed by the Clerk.

2. To receive nominations for the post of Vice- Chairman and elect a member to the post.

Chair Bass proposed Councillor Bateman, seconded by Councillor Spain. No other proposals were made. A vote by secret ballot took place and Councillor Bateman received 7 votes for and 1 vote against and 1 blank. Thereafter Councillor Bateman signed the acceptance form and this was co –signed by the Clerk.

Councillor Curtis asked that the bottom of the trees along the edge of 1-4 Eastgate and the War Memorial be lifted as they were impacting on visibility- The Clerk to report to NCC. The SNAP meetings recently attended have agreed their focus will be on youth engagement and the vulnerable and elderly – particularly around scams.

Councillor Hicks reported the footbridge into the allotment area was very wobbly and needed to be looked at again and repairs undertaken. The Clerk to contact the landowner

Councillor Bateman confirmed that representatives from National Highways and Taylor Woodrow would be at the Queen Elizabeth Memorial Wood on 6th June at 11.00am to assist with the planting of the remaining 20 trees they provided as part of the replacement programme for the junction improvement at the Tuns Road/A47

- Co option Policy- proposed by Councillor Spain, seconded by Chair Bass and agreed unanimously
- Financial regulations- adoption of the new NALC model version proposed by Councillor Bateman, seconded by Councillor Hayton and agreed unanimously

15. To decide if Neighbourhood Watch signs can be placed on various lamp posts in the village

After discussions Councillor Bateman proposed signs were installed around the village and the exact number and locations would be discussed at the next action plan working party meeting on 7th June so that these can be approved and the next full Council meeting. Seconded by Councillor Jennings and agreed unanimously

16. To discuss and decide on a further community event to provide information on frauds and scammers

Chair Bass proposed a further event should be held and that it could encompass and include the surrounding villages, noting Councillor Curtis to liaise with the Police to explore options and dates. Seconded by Councillor Jennings and agreed unanimously.

17. To decide if the Parish Council will attend and take part in the upcoming Community surgery being held by George Freeman MP

Councillor Bateman proposed the Parish Council should attend and take part in the surgery. Seconded by Councillor Hicks and agreed unanimously. Noting Councillors Bass, Bateman and Spain will represent the Council at the event.

18. To discuss and decide if correspondence should be sent to Simon Wood @ Breckland or whether to request a meeting in regards to updates on the main application to them from RWE (previously Vattenfall)

Councillor Spain proposed that the Clerk email Simon Wood at Breckland to request a meeting with him and representatives from RWE to ascertain the current position and receive a progress report. Seconded by Chair Bass and agreed unanimously

Councillor Jennings left the meeting at 8.45pm

19. To decide on content of correspondence to be sent to RWE requesting additional and wider sedimentary traps

Councillor Spain proposed the Clerk should contact the Environment Agency, Simon Wood and Nigel Wilkin (both Breckland) in regards to run off from the site works on the A47 requesting action to be taken. Seconded by Chair Bass and agreed unanimously.

20. To consider and decide if correspondence should be sent to National Highways regarding the 'keep left' bollard at the Tuns Road / A47 junction and what the content should be.

Councillor Bateman proposed the upcoming tree planting event with representatives from Highways and Taylor Woodrow on 6th June should be used to show them the issues at the junctions with the signage and other snagging and remedial works required. Seconded by Councillor Fejer and agreed unanimously.

Councillor Hicks left the meeting at 8.55pm

21. To discuss and decide if the Parish Council wish to comment on the new council ward and ward boundaries as part of Breckland Council's consultation period

Councillor Bateman proposed the comment from Necton PC should be "Necton Parish Council is in favour of single member Wards', seconded by Councillor Spain and agreed unanimously
